

# K-REACH Compliance Service

The Act on Registration and Evaluation of Chemicals, also known as K-REACH, was officially implemented on January 1, 2015. The main purpose of the Act is to establish a chemical substance management system for chemical substance registration, risk assessment, authorization and restriction in order to protect human health and environmental safety. It requires that all new substances and over 1 ton per year of existing chemical substances manufactured in or imported into Korea be subject to notification or registration obligations prior to manufacturing or importation activities. Registerd Suppliers of Chemicals need to transfer information to downstream users or distributors.

On March 20, 2018, the Korean Ministry of the Environment (MoE) issued the amendment to K-REACH, which was implemented on January 1, 2019.

### **Key Points of K-REACH**

- Chemical Substance Registration, incl:
  - Registration for new chemical substance >=0.1ton/year
  - Notification for new chemical substance <0.1ton/year
  - Pre-Registration for Existing Chemical Substance>=1ton/year
  - Existing Chemical Substance Registration >=1ton/year
  - Registration for 510 PEC Substance in previous >=1ton/year
- Exemption for PLC substance
- Exemption for Research and development(R&D) substance

### 《韩国化学注册与评估法案》

(The Act on Registration and Evaluation of Chemicals 又称化评法, 简称K-REACH) 干2015年1月1日起正式实施。该法规 是为了保护人体健康和环境安全而设 立的化学物质注册、风险评估、授权和 限制的化学物质管理制度。法规要求 韩国境内生产或进口的所有新物质以 及超过1吨每年的已有化学物质履行 通报或注册义务,已注册的供应商需 要向下游用户或者分销商共享化学 物质的相关信息。

2018年3月20日,韩国环境部 (MOE) 发布《韩国化学物质注册与评估法案》 修订案,并于2019年1月1日开始实 施。

# 法规重点 Key Points of K-REACH

- 化学物质的注册,包括:
  - -新化学物质的注册(≥0.1吨/年的新化学物质需要正式注册)
  - -新化学物质的通报(<0.1吨/年的新化学物质需要通报)
  - -已有化学物质预注册(≥1吨/年的已有化学物质预注册)
  - -已有化学物质正式注册(≥1吨/年的已有化学物质需要在相应时间节点之 前完成正式注册)
  - -指定的已有化学物质的注册(旧指南规定的≥1吨/年的第一批需要注册的 物质需要正式注册)
- 低关注聚合物的豁免确认
- 用于研究开发用途的化学物质的豁免确认
