

# 台湾地区化学品登录

### (TCCSCA/OSHA)

台湾地区《毒性及关注化学物质管理法》(以下简称《毒管法》)规定,现有化学物质和新化学物质在台湾地区生产和进口之前,须向台湾地区"环保署"申请登录,经批准后才可以进行生产和进口活动。

《毒管法》的子法《新化学物质及既有化学物质资料登录办法》(以下简称《办法》)规定,中央主管机关可依既有化学物质资料第一阶段登录情形,分期指定应完成既有化学物质标准登录的名单、数量级距及登录期限。

《办法》附表九中列明了106种化学物质即为第一批指定标准登录的既有化学物质、数量级距及登录期限。针对新化学物质,凡是在台湾地区生产和进口的新化学物质,根据不同的吨位量级、物质类型及用途分别进行少量登录、简易登录和标准登录。


《办法》还规定了对年报的要求,即从2020年起登录人需在每年的4月1日至9月30日对核准登录的物质上一年度的生产量和进口量向主管机构进行报告。

# **Taiwan Region**

### TCCSCA/OSHA

In accordance with Article 30 of the Toxic and Concerned Chemical Substances Control Act (TCCSCA, revised in 2019), enterprises that manufacture or import certain quantities of existing chemical substances each year shall submit the registration dossier of chemical substance to the competent authority before the specified deadline.

In accordance with Article 16 of the Regulations of New and Existing Chemical Substances Registration (Sub-regulation of TCCSCA, revised in 2019), stipulates that: The central competent authority announced designated lists of existing chemical substances subject to standard registration in stages, including quantity threshold and the time limit for registration. based on the conditions of Phase I Registration of existing chemical substances. The 106 designated chemical substances in Annex VI are the first priority substances to conduct the registration from Jan 1, 2020. New substances should be registered as small quantity registration, simplified registration, or standard registration according to different tonnage bands, substance properties and usage.

From 2020, registrants need to report the annual manufacturing/importing tonnage of the last year to the competent authority between 1st Apr. and 30th Sep. each year.
